### **Champaign County Association of REALTTORS®**

#### Affiliate Keyholder Holder Policy / Agreement

- 1. The CCAR Board of Directors must have approved your application for Affiliate Membership.
- 2. Provide a copy of your valid **business license** with the completed Affiliate Keyholder Policy/Agreement.
- 3. **Provide a Certificate of Liability Insurance** of at least \$1,000,000.00 naming the Champaign County Association of REALTORS® as an additional insured.
- 4. A fee of \$435 and completion of this Affiliate Keyholder Policy/Agreement, signed by the Keyholder and the Company Owner, is required to issue a Supra eKey. Supra requires a credit card to be placed on account. The monthly fee of \$17.18 is billed by Supra, to be amended annually.
- 5. Those eligible for consideration currently are State Licensed and/or bonded Affiliate Members of CCAR.
  - a. Use of the eKey/Key boxes shall be governed by the terms and conditions of the Affiliate Keyholder Policy/Agreement.
  - b. Ekey/Keybox use is not an open invitation to enter the property. Appointments are mandatory and should be made in accordance with the set procedures of the Association. Affiliate Members are expressly prohibited from using eKeys to enter a property without the Listing Broker's permission. Furthermore, the keyholder may not be accompanied by any person(s) including but not limited to the Lender, or any non-employee of the Affiliate. The eKey is not to be loaned to any person, whether a real estate licensee, for any personal purpose whatsoever and is not to be used for any purpose by any other person. A fine of \$1,000.00 will be levied on any keyholder found in violation. Affiliate Members may have their membership suspended if reasonable suspicion exists that rules have been violated. Upon request, a hearing may be held within 30 days of the suspension.
  - c. Keyholders who have violated any of these provisions one time within a 12-month period shall receive a warning from the Association. If a second violation occurs within a 12-month period, the keyholder shall forfeit all eKey/Key box privileges for 30 days. If a third violation occurs, all eKey/Key box privileges shall be forfeited and deactivated.
  - d. Any eKey services will be deactivated when the Affiliate Membership is terminated.
