

OVERVIEW OF THE APPLICATION PROCESS

We are pleased that you are interested in joining the Champaign County Association of REALTORS® (CCAR). Membership with CCAR opens the door to a wide variety of services and opportunities that are available nowhere else. It also carries with it financial and ethical responsibilities designed to enhance the professionalism of the industry. The application process is a relatively simple one; however, there are some procedures and policies with which you should be familiar with. Membership application requirements:

- 1. A fully completed and signed CCAR Application.
- 2. A copy of the 45-day permit or documentation of license sponsor at IDFPR.
- 3. Applicant Acknowledgment signed by both the applicant and their Designated Managing Broker.
- 4. Payment of applicable dues and fees are required at the time of application. (See Annual Dues/Membership Fees below)

After submitting your application and paying the required dues and fees, you will be scheduled for basic MLS and e-key training.

New Member Orientation Requirement

- You <u>must</u> attend the next available two-day CCAR Orientation following approval of your application. (See the Orientation Schedule below)
- If you miss any of the mandatory orientation segments, you will be required to make up the entire segment the next time it is offered.
- If the required orientation courses are not completed within the specified time frame, your MLS and E-key services will be suspended until the requirement is fulfilled.

Following orientation, you will be formally inducted into the Champaign County Association of REALTORS® (CCAR) at our next member luncheon.

Membership Classifications

- 1) Primary Designated REALTOR® Membership: A licensed real estate managing broker or appraiser in Illinois, designated as the primary point of contact for their firm, who is not currently affiliated with any other REALTOR® board or association.
- 2) **Primary REALTOR® Membership:** A licensed real estate broker or appraiser in Illinois, affiliated with a current CCAR member office, but does not hold current membership in any other board or association.
- 3) Secondary Designated REALTOR® Membership: A licensed real estate managing broker or appraiser in Illinois, designated as the primary point of contact for their firm, who is currently a primary member of another board or association and also chooses to be a member of CCAR. A letter of good standing from your primary board or association must be included.
- 4) Secondary REALTOR® Membership: Licensed real estate broker or appraiser in Illinois who is currently a primary member of another board or association and chooses to be a member of CCAR. A letter of good standing from your primary board or association must be included. Note: Your Designated Managing Broker must hold primary or secondary membership with CCAR for you to qualify for secondary membership.
- 5) MLS Subscriber: A licensed real estate broker or appraiser in Illinois, affiliated with another board or association and enters into an agreement with CCAR to subscribe to their MLS (MRED). Note: Your Designated Managing Broker must hold primary or secondary membership with CCAR for you to be an MLS Subscriber.
