

CCAR SCHOLARSHIP CRITERIA

This scholarship may be used by the recipient for any real estate—related educational courses toward professional designations, but not for continuing education required for license renewal.

To be eligible for a CCAR Scholarship, an individual must:

Be an active REALTOR® member of CCAR for at least one year and have served on at least one Committee.

Have not received the benefit of this scholarship within the last 12 months. Any actively awarded scholarship not used within 12 months will be forfeited.

Be a permanent resident of Illinois within Champaign County and the surrounding areas.

Have completed a real estate-related educational event within the past 12 months.

The Application Process

Applicants should submit their application with all supporting materials via email to gabbyp@illinihomes.com or by mail to CCAR, 305 Burwash Ave., Savoy, IL 61874.

Please return one letter of recommendation from someone outside your office, and a cover letter explaining your personal goals for your real estate career with your completed application.

The Selection Process

Scholarships are reviewed and evaluated on a specific set of criteria by the Professional Development Committee of CCAR and approved by the Board of Directors.

Applications are reviewed for approval as they are received, and the length of the determination process may vary.

The monetary value of the scholarship varies based on the need and request of each application.
