



HELEN STAFFORD SCHOLARSHIP CRITERIA

Helen, affectionately known as “Selling Helen” in the real estate business during the 60’s and 70’s, was about living and learning. The Helen Stafford Scholarship encourages REALTORS® to grow in their knowledge by gaining a Designation or Certification and shall be used by the recipient for any real estate related education for Designations or Certifications, including ABR, CCIM, CR’s, GRI, and more. In addition, to be eligible for the Helen Stafford Scholarship, an individual must:

Be an active member of CCAR no longer than five years and have served on (and attended the required 75% of meetings) at least one CCAR Committee for a minimum of one year.

Have not received the benefit of this scholarship within the last 24 months.

Be a permanent resident of Illinois within Champaign County and the surrounding areas.

Completed a real estate-related educational event within the past 12 months.

The maximum possible award is \$250.00. An individual who receives a Helen Stafford Scholarship may also apply for CCAR Scholarships.

The Application Process

Applicants should submit their application with all supporting materials via email to gabbyp@illinihomes.com, or by U.S. Mail to CCAR, 305 Burwash Ave., Savoy, IL 61874.

Scholarships are reviewed and recommended by the Professional Development Committee of CCAR and approved by the Board of Directors. Applications are reviewed for approval throughout the year, as they are received, and the length of the determination process may vary.
